(a) **"2022 Agreement"** means the contract that was formed between the 1st and/or 2nd Plaintiff and the 1st and/or 2nd Defendant during the meeting on 1.8.2022.

(b) **"KL Tower"** means the Kuala Lumpur Tower, also known as Menara Kuala Lumpur, or just Menara KL.

(c) **"Award"** means the 1st and/or 2nd Defendant's decision made in May 2024 to award the concession over the KL Tower to the 3rd Defendant.

(d) **"Chose in Action"** means the concession over the KL Tower.

(f) **"VM Lab Works"** means the maintenance and improvement works, the scope of which was defined in the Value Management Laboratory report signed by the Ministry of Communications and the 2nd Plaintiff on 22.3.2021.

(g) **"Interim Fee"** means the sum of RM500,000.00 per month to be paid by the 1st and/or 2nd Defendant to the 1st and/or 2nd Plaintiff throughout the validity of the 5th Supplemental Agreement dated 1.7.2024, totalling RM4.5 million, as consideration for 1st and/or 2nd Plaintiff's agreement to the 5th Supplemental Agreement dated 1.7.2014.

Declaratory Reliefs

- (1) A declaration that the 2022 Agreement is valid and binding against the 1st and 2nd Defendant; and/or
- (2) A declaration that the 1st and 2nd Plaintiff is entitled as against the 1st and 2nd Defendant to the concession over the KL Tower for 30 years from 31.12.2024; and/or
- (3) A declaration that the 1st and 2nd Defendant has breached the 2022 Agreement; and/or
